CONSTRUCTION OF KISUTU MORDEN MARKET

1. Ilala Municipal Council has set aside funds for Construction of Kisutu Morden Market and it intends to apply part of the proceeds of the funds to cover eligible payments under the contract for the Construction of the Proposed **Kisutu Modern Market in Ilala Municipality**.
2. The Ilala Municipal Council now invites sealed tender from the interested Bidders for carrying out the construction of the Proposed **Kisutu Modern Market at Ilala Municipality**.
3. Bidding will be conducted through the National Competitive tendering procedures specified in the Procurement (Goods, Works, Non Consultancy Service and Disposal of Public Assets by Tender) Regulations, 2013 – Government Notice No. 446 and is open to all Bidders as defined in the Regulations.
4. Qualifications requirements for the works include: (i) experience as prime contractor in construction of at least two works similar nature and complexity in the last five years (ii) minimum annual volume of construction work for the last five years of **5 billion** or equivalent (iii) minimum amount of liquid assets and/or credit facilities net of other contractual commitments of **2 billion** Tanzanian Shilling or equivalent and class one building Construction Company.

Interested eligible bidders may obtain further information from and inspect the bidding documents at the office of **The Secretary , Ilala Municipal Council Tender Board, allocated at Municipal Depot Office, Room No. 1, Nyerere Road adjacent of Mkuki House, P.O. Box 20950, Dar es Salaam, Tanzania**, from 07.30 to 15.30 hours local time, Monday to Friday except on public holidays.

7. below and upon payment of non-refundable fee of **TShs 200,000.00 (Tanzania Shillings Two Hundred Thousand Only)**, payable by Cash to **Municipal Director, Ilala Municipal Council, 1Mission Street, P. O. Box 20950, Dar es Salaam, Tanzania.**
8. Bids must be delivered to **The Secretary, Ilala Municipal Council Tender Board, Municipal Depot, Office of the Procurement Management Unit (PMU), Room No. 1, Nyerere Road adjacent Mkuki House, P.O. Box 20950, Dar es Salaam, Tanzania** at or before **10:00 am** on **Monday February 19, 2018.**

All Tenders must be accompanied by a Tender security in an acceptable form in the amount equivalent to 2% of the **Bid Price in form of Banker's Cheque or Irrevocable Letter of Credit**, properly addressed to the **Municipal Director Ilala Municipal Council, 1Mission Street, P.O Box 20950 Dar Es salaam** valid for **28 days beyond the bid validity period.**
